It is Grantor's intention to market the lots and future homes in Brady Neighborhood Development to individual owners. The City of Port Townsend is requiring abutting property owners to maintain those portions of public trails abutting their premises located in the Brady Neighborhood Development legally described above. In order for these owners to mutually enjoy the benefit of a public trail system, it is necessary to make this agreement.

Owners of property in Blocks 4, 5, 16 and 17, abutting a trail located in the public rightof-way shall maintain that portion abutting their property. Maintenance includes not altering the existing landscaping and trail, removing any debris on the trail, and not encroaching or interfering with the use of the trail by the public.

Amendment. This Trail Maintenance Agreement may be modified or amended in whole or in part only by a written instrument executed and acknowledged by the parties, and the City of Port Townsend, which instrument must be duly recorded in the official records of Jefferson County, Washington.

Governing Law. This Trail Maintenance Agreement shall be construed and governed in accordance with the laws of the State of Washington.

Counterparts. This Trail Maintenance Agreement may be executed in any number of counterparts. Each counterpart shall be deemed an original and all counterparts shall be deemed the same instrument with the same effect as if all parties hereto had signed the same signature page.

Entire Agreement. The parties acknowledge and agree that this Trail Maintenance Agreement constitutes the entire agreement between the parties hereto as to the rights herein granted and the obligations herein assumed. Any oral representation or modification concerning this instrument shall be of no force or effect, excepting subsequent modifications in writing, signed by the party to be charged and recorded in the official records as set forth above.
